The roof at the Eppson Center needed repairs to cease water seepage from the large roof into the dining hall, hallways and meeting/workout space. A member of our club serves on the Eppson Center board of directors and brought the issue to the club's attention.

Members of our club frequent the Eppson Center for meals and services provided there.

Director Tammy Comer reports the grant money from our club and Rotary district 5440 Centennial Match covered the entire expense of repair work conducted by Gem City Roofing company in Laramie. Director Comer is grateful for the partnership with Laramie Sunrise club.

3. How many Rotarians participated in this project? All LS club members voted to approve the project and 75% of members attended the check award ceremony at the Eppson Center. Members were not qualified to complete the work itself; only professionals were allowed to be on the roof of the center.

5. How many non-Rotarians benefited from this project? **This project benefitted the 60+ members of Albany county that go to the Center for meals. Some of these county members may or may not be members of Laramie's Rotary club (100+ members)**

Who are the beneficiaries and what is the expected long-term community impact of this project? **The long-term impact will be that the Center will be able to move on to needed repairs that exist in the dining room, hallways and meeting/workout space that were damaged by water seepage through the roof.
