Project Title: Reveille Rotary Smoke Alarms

Project Description:

1. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

Reveille Rotary Club is in the 5th year of partnering with the Casper Fire-EMS Dept. and the Natrona County Fire-EMS departments to serve senior citizens and homebound residents within about a 20 mile radius. The focus is to prevent recipients from using ladders and preventing falls as well as life safety through early fire notification. Recipients are identified through the Senior Center and Meals on Wheels programs and installation of the alarms are provided by volunteers from the Reveille Rotary Club twice per year around the time changes. Training and assistance to our volunteers is provided by the Casper Fire-EMS Dept. Community Risk Division. Funding will be used to purchase smoke and CO alarms through a bulk purchase program. Reveille Rotary Club has 38 members and has served over 450 recipients with smoke alarms in the last 4 years.

2. How many Rotarians participated in this project? 24 Rotarians and 60 other community and fire-ems volunteers
3. What did they do? Please give at least two examples.

Within the three days of installations, Rotarians and volunteers attended a training session before each installation period. Then the Rotarians and volunteers broke out into teams of 3 and visited an average of 4 homes per team, installing smoke alarms, carbon monoxide alarms and night lights. All recipients met the criteria of seniors or homebound.

4. How many non-Rotarians benefited from this project? 125
5. Who are the beneficiaries and what is the expected long-term community impact of this project?
The beneficiaries are the senior citizen home occupants and their families, both resident within the home and non. The Fire-EMS departments also benefit from knowing that these homes are protected.

6. If a cooperating organization was involved, what was their role?
 The 9 City and County Fire stations plus fire administration were involved. The lead administrative GIS specialist prepared all of the maps, one per home, entered all data on a master spreadsheet. They also host the website where all locations are shown:

 Every home address who is a recipient is on the registry and will get revisited in 10 years for replacement smoke alarms and carbon monoxide alarms, as the batteries are scheduled to last 10 years, then will need replaced.
