Project Title Arroyo Trails

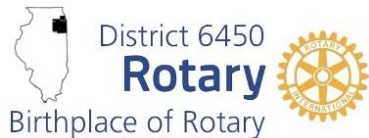
1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? List any changes that might have occurred.
 Arroyo Trails is an initiative spearheaded by a group called the People for Channahon Parks Foundation, in an effort to develop a new community park site in the Channahon and Minooka area. Members of the Channahon-Minooka Rotary Club has been integrally involved in the process to secure, plan and facilitate the formation of the park.
2. How many Rotarians participated in the project? Several Rotarians have been involved in the processes involved, but there have been six involved to a greater degree than others.
3. What did they do? Please give at least 2 examples.
 Two of the members include the former and current Park District Director, both of whom have taken a leadership role in both the planning and execution of the park formation process. Additional members have been heavily involved in the process to secure funding for the project, including applying funds for signage at the site.
4. How many non-Rotarians benefitted from this project?
 The population of our immediate community is around 27,000 who will have immediate access to the amenities, but the range is hoped to be much greater.
5. What are the expected long-term community impacts of the project?
 Long-term, the Arroyo Trails Park will provide educational, recreational and cultural opportunities for our residents of all ages and abilities. Financially, it will boost the local economy as people travel to visit the park and hopefully avail themselves of our local services.
6. If a cooperating organization was involved, what was its role?
 The People for Channahon Parks Foundation has been actively fundraising towards this project.
7. How did you share the news of your project? News was shared on our social media platforms, and we care continuing to pursue coverage by a local newspaper.
