Project Description. What was done in 110 words or less? The Parker Rotary Club decided to support the county-wide animal shelter after hearing a presentation from the Animal Relief Fund, which is a volunteer organization that supports our shelter. We appointed a member to take the grant training in 2018, wrote the grant, and purchased two sets of six stainless steel kennels to expand the capacity of our shelter. Members received regular updates on the progress of the project and it was completed with the delivery of the kennels in April, 2019.

When (dates) and where (city and state) did the project take place? The project was started on June 29, 2018 and was completed on April 11, 2019 with the presentation of the kennels. Final report was submitted April 30, 2019. This project was for the La Paz County/Town of Parker Animal Shelter in Parker, AZ.

Who were the beneficiaries? This project benefitted the La Paz County/Town of Parker Animal Shelter in Parker, AZ.

How many Rotarians participated in this project? 30 members participated

What did the Rotarians do? Give at least two examples. The members held fundraisers, including The Desert Dash (a walk/run/bike event for all ages. We have participants from around the world who come to Parker, AZ to enjoy our mild winters. Also, the members had a presentation from the Animal Relief Fund, a volunteer group that supports the shelter. They spoke about the various needs of the shelter.

After the presentation the members discussed the possibility of applying for a grant to help support the project, which they decided to purchase new kennels to expand the capacity of the shelter.

How many non-Rotarians benefited from this project? Approximately 21,000 residents live in the county and benefit from the services of the La Paz County/Town of Parker Animal Shelter.
