Project Title: Kid Fish

Project Description

1.Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? On Saturday, May 11th, the Rotary Club and Lions Club of Breckenridge sponsored a free, community-wide fishing event for kids 16 years of age and under at the "Frog Pond" next to the Stephens County Animal Shelter. Despite cold, rainy weather around 49 kids and their families came to the pond to fish. Estimates are that 119 fish were reeled in during the 4 hour event. Tackle boxes were awarded to those catching the largest and smallest fish; the largest being a 10 inch bass and the smallest a 3 inch perch. All kids were treated to free t-shirts, hot dogs, chips, and drinks. The fishing gear was provided by the Rotary and Lions, bait was donated by the Hubbard Creek Catfish Club, and prize tackleboxes by Higginbotham's.

Rotarians helped "rig" poles with line, hooks, and weights; took pictures; measured and documented fish; distributed t-shirts

The intent of the program is to bring families together, to provide fishing opportunities for kids that do not normally have such opportunities, and to provide experienced anglers to teach kids how to fish. The Rotary Club and Lions Club plan to sponsor the event again next year.

Texas Game Warden Cliff Westbrook and Fire Chief Calvin Chaney were on hand to help out and lend assistance in helping the kids safely cast their lines and remove fish from the hooks.
