Christmas gifts were collected, sorted and distributed to almost 900 underprivileged children in 11 communities in and around LaGrange and serviced by Pillars Community Health. Additional gifts needed for distribution were purchased with the grant money.

Sent letters to families, collected and logged information on children to receive gifts, distributed collection boxes, gathered donations and shopped for needed items, sorted gifts into bags for specific children, and distributed gifts to families.

Contributes to the mental health of the community by bringing the joy of Christmas to a great many children and their families and creates a bond in the community between the volunteers.

The Park District of LaGrange provided permanent space for storage and distribution. A group of about 40 "elf" volunteers provided collection, sorting and distribution labor.
