If outside hard liquor is opened and consumed on the premises the entire group may be asked to leave without refund.

Deposit and Payment Information -

A 0.00 DEPOSIT IS DUE UPON BOOKING EVENT. PAYMENT IN FULL IS DUE ON OR BEFORE THE DAY OF YOUR EVENT. Arrangements can be made to be invoiced after your event. Groups must pay in ONE PAYMENT to receive the group discount. Prices do not include 6% Idaho sales tax. For bowling-only groups, payment for the lanes is due in full upon booking. Payments may be made via major credit card, cash, or corporate check made payable to Blackmor LLC/Wahooz. Prices subject to change.

Cancellations -

Notice of cancellation must be given by group leader 10 BUSINESS DAYS to event date on all catered events. If client fails to cancel event ten days prior, some or all of non-refundable deposit may be kept by Wahooz, Pinz, the Galaxy or Roaring Springs. If we haven't received a deposit we will invoice you for the amount due per the schedule below.

Minimum count for play packages -

A minimum of 10 guests are required for discounted group play packages at Wahooz or Pinz and 15 guests at Roaring Springs. You will be charged the play portion only for guests in attendance. Bowling lane assignment subject to change.

Weather -

Some attractions at Wahooz or Roaring Springs may be unavailable due to inclement weather. If this occurs on the date of the event, we will exchange your package for another package that will accommodate your group. Wahooz and Roaring Springs reserve the right to make any exchanges they feel appropriate or necessary. We may also work with you to reschedule your event.

Special Instructions -

Any special instructions or considerations must be reflected on this agreement or in writing and agreed upon by the client and their Group Sales Representative. Any changes or additions will be prepared by a Group Sales Representative and will be sent to you as an updated contract. Wahooz, Pinz, the Galaxy, and Roaring Springs will not be required to accommodate any unwritten requests on the day of the event.

Prohibited items -

Firearms or any item that could be used as a weapon, concealed or otherwise, is not allowed on the premises regardless of licenses.

The Galaxy does not allow confetti, glitter, straw or hay bales, aerosol spray string, unshelled peanuts, or other items that cause an


excessive mess. An open flame of any type, typically candles, as well as all pyrotechnics are prohibited. All decorative materials must be flame retardant.

Gratuity & Tax -

An 18% gratuity will be added to all group events for the food & beverage portion only. 6% Idaho Sales tax will be added to all contracted items, except gratuity. Tax exempt groups must provide an ST-101 form in advance of their event.

Outside Food & Drink -

NO OUTSIDE FOOD OR BEVERAGE ARE ALLOWED. No to go boxes on any catered events.

A copy of this certificate must be provided to the Galaxy at least seven days prior to your event. A new certificate of insurance is required from each vendor with each event.
