Our Club worked with counselors at Lincoln Way West, Central and Providence Catholic High Schools to identify higher education bound students. On the counselors' recommendation 4 students were selected at Lincoln Way West and Central and two at Providence. Scholarship funds were disbursed to the counselors in April to distribute to the students. Typically we would invite the students and their parents/guardians to attend a meeting in order for us to have the opportunity to meet them but with COVID-19 still interrupting normal operations, we felt it best for the school personnel to distribute the scholarship funds.
- How many Rotarians participated in the project?
There were 25 Rotarians that participated in the project.

The Rotarians were in contact with school counselors to identify the students and the scholarship criteria and the group as a whole decided on our Club's contribution to the project.

There were a total of ten non-Rotarians that benefitted from the project.

The long-term community impacts will be educated individuals who will return to their origin of upbringing to contribute as mentally nimble, adaptable, and creatively innovative in tackling business and industry challenges as they become future leaders.
