1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?  
 We set up a grant program to benefit students of local schools that serve our community, specifically the city of Anaheim Hills. Anaheim Hills Rotary Club (AHRC) publicized the program to get teachers etc from the local schools to request grants that will benefit the students and the schools. This year, this process was complicated and drawn out due to the impact of the Covid-19 pandemic. Once we received a sufficient number of requests, a committee of AHRC members analyzed the grant requests for appropriateness and

 The STEP program is run by Dene Olsen, Chair of Vocational Service and member of the board, with assistance by George Gillespi. Dene created and sent emails to communicate with schools that serve students of Anaheim Hills. Additional programs were also used to communicate and publicize this program to the appropriate teachers and schools. The teachers were encouraged to apply for grants, up to A committee of 7 additional AHRC members was organized, the members whom helped evaluate the grant requests and all of these members were then responsible for handling a certain number of the approved grants. The committee members purchased the materials and supplies and arranged for delivery of them to fulfill the approved grants.

4. How many non-Rotarians benefited from this project?  
 (Others than incidentally, no Rotarians benefited from this project). Hundreds of students and teachers benefited from this program because various materials and supplies went to classrooms and libraries where many students benefited. Most of the funded projects will continue to support additional students for many years to come.

5. What are the expected long-term community impacts of the project?  
 The students, teachers, and schools benefit in various amounts and times depending upon the individual grant. Quite a few of these grants result in benefits to many students across many years. For example, additional books and resources in the library is an example of a benefit of something that will benefit multiple students for a number of years. Another example, resources that benefit a classrooms at the middle and high school level will benefit multiple classrooms for all the periods served by that classroom across multiple years. Since the items purchased are designed to enhance learning, students may reap benefits through the rest of their education and into life beyond.
