Rotarians teamed up with the Parks Department to help with the installation of the Ruby Falls Play Equipment and a 4-way Test Sign at the entrance of the park. The equipment was installed on the newly created beach at Brown Park in McCall, ID in July, 2022. It provides youth and families a unique and educational experience while at play with water and sand in a safe environment. It helps children learn about hydrology by demonstrating changes to water flow through a play element.

All activities took place at Brown Park in McCall, Idaho.

4. In one brief sentence: who were the beneficiaries of the grant activities and how many of them were there?

The beneficiaries are community members and visitors who enjoy spending time at Brown Park. Approximately 75 – 100 community members attended the Grand Re-opening. Locals and visitors benefit from the play equipment daily and will for many years to come.
