### MEMORANDUM OF UNDERSTANDING

This Agreement (hereafter referred to as the Memorandum) has been made between ITT VOCATIONAL TRAINING CENTRE UGANDA (here in after referred to as the Corporate Organization on the other part) and BUGIRI MUNICIPAL COUNCIL (here in after referred to as the Beneficiary Agency on the other part)

Whereas the Corporate Organization has secured partnership with the Rotary Club of Iganga for purposes of implementing T4L (Toilet for Life Project),

Whereas, the beneficiary Agency is desirous of accessing its population to modern toilet facilities,

Whereas the Corporate Organization and the beneficiary have accepted to enter into partnership under the T4L project,

It is now agreed as follows;

#### 1.0 GENERAL

- (a) That both parties accept to bind themselves to each other in this memorandum
- (b) That no party may revoke this memorandum without giving the other party due notice
- (c) In case any party wishes to revoke this memorandum, it may do so ordinarily in writing giving the other party due notice of 90 days
- (d) In pursuance of (c) above, the memorandum will be deemed to have been revoked if here is mutual acceptance and agreement of both parties.



## 2.0 Obligations of the Corporate Organization

- That the corporate organization will undertake to carry out the general construction work under the project.
- 2. That the corporate Organization will undertake to monitor and supervise the project activities
- 3. That the corporate Organization will undertake to mobilize equipment and plants to the project site (s)
- 4. That the corporate Organization will undertake to certify the quality and standards of materials at the project site (s)
- 5. That the corporate Organization will undertake to empty filled toilets regularly.

## 3.0 Obligations of the Benefiting Agency

- That the benefiting Agency Shall undertake to make provisions for operation and maintenance costs,
- That benefiting Agency shall undertake to provide for the security and safety of equipment, Plants and Materials.
- 3. That the benefiting Agency shall undertake to provide construction materials (bricks and sand)
- 4. That the benefiting Agency shall undertake to provide land for installation of the project (s)
- 5. That the benefiting Agency shall undertake to keep the utilities clean and under proper use at all times.
- That the benefiting Agency shall undertake to maintain functional hand washing facilities at the utilities.
- 7. That the benefiting Agency shall undertake to provide for easements at the following sites for ease of the project construction.

  - ii) NALUWERERE TRAILER PARK
  - iii) BUGIRI BUS PARK
  - iv) / ITT CAMPUS
  - v) BUGIRI TAX PARK
