

## **WARRANTY**

Services will be provided during the warranty period for each installed equipment, as well as technical assistance during business hours for non-scheduled corrective events, intended to correct technical failures of the equipment during the warranty period.

Post-warranty maintenance contract (optional): It is optional to the BUYER to purchase labor services for preventive and corrective maintenance after the warranty period.

## **CONDITIONS**

- It is the responsibility of the customer to supply and install electrical circuits necessary to power the various equipment;
- It is the customer's responsibility to supply medical gas pipes as well as adapters for hose connections;
- Term of guarantee of the pulmonary ventilator: 12 (twelve) months from the date of delivery of the equipment;
- Warranty services will be provided exclusively for manufacturing defects in the equipment and will be provided in the buyer's premises;
- General consumables (batteries, oxygen cells, electrochemical sensors, disposables and any item that can be classified as such) are not included;
- No preventive or predictive maintenance services are included in the warranty;
- Ancillary services such as pre-installation works, validation and/or thermal qualification, hydrostatic test, structural tests or tests, electrical network and/or gas evaluation and calibration are not included in the guarantee;
- Conditions for loss of guarantee will be governed by the purchase agreement;
- Technical Assistance during and after warranty termination will be provided by Getinge or one of its authorized and trained representatives;
- Proposal valid for 30 (thirty) days from the date of issuance of this offer.
- It is the responsibility of Getinge or its trained and certified representatives, a user training for the care team in the following shifts, 01x morning and afternoon and 02 night periods (01 night par and 01 odd night).

## **DOMAIN RESERVE**

It is established among the PARTIES, a reservation agreement of domain of the Equipment in favor of the SELLER, which will persist until the total settlement of the full value of this instrument by the BUYER.

By virtue of the domain reserve agreement hereby established, the BUYER will be constituted as the sole owner of the Equipment, acknowledging that these will remain the exclusive property of the SELLER until the total settlement of the value.

The BUYER may freely use the Equipment, but in a manner compatible with their respective purposes, the removal of the place where they are installed is prohibited. THE BUYER acknowledges that it will not be able to lend, sell, assign, or otherwise dispose of the Equipment, for any title, until it has been transferred to them by full liquidation.

Payment of the price in the form contracted, the reservation of domain will be considered automatically extinct, consolidating the definitive ownership of the Equipment in favor of the BUYER.

It is hereby established that, until full payment of the Price, the BUYER undertakes to;

(I) keep the Equipment a perfect state of use and conservation, free and unencumbered of any liens, charges or encumbrances, protecting them against any disturbance of third parties, and must take all necessary measures for this purpose; and

(II) permit, upon prior scheduling, inspection of the Equipment by an accredited representative of the SELLER.
