COMMUNITY OVERVIEW

The Lusaka Metro area has a population of over 3,324,000 people with most living in the high density residential townships commonly known as "Compounds". In these areas, we find the most underprivileged members of society who eke out a living as traders and vendors, with a very few number being formally employed. Government Health Facilities are available in each township but are generally overstretched in providing health care due to lack of equipment and funding issues. Patients and medical samples are frequently referred to the next level hospitals leading to extra costs and delays by patients in receiving medical attention.

Describe the process of how the beneficiaries were identified.

 Over the years, the Rotary Club of Nkwazi has been working with the Ministry of Health in various Projects. It was during the visits to a Health Centre in the company of D6460 USA Group Study Exchange that we confirmed the dire need for hospital equipment and medical supplies. We interviewed the Health Staff. We later met patients and community leaders in follow up visits.

- Availability of medical equipment, supplies and consumables leading to better health service delivery
- 2. Prompt service to patients without having to wait too long in queues or being referred to other Facilities and would therefore look for money for transport.
- 3. Safe working environment with the right tools for job for health professionals to enable them to give quality health service to patients.

- 1. The Community have a strong desire to improve their welfare and work as a cohesive team
- Health staffs are dedicated to duty, patient and resilient and give their best under the circumstances. They therefore have the potential to give better quality service

- 1. The Communities are impoverished and cannot afford private medical care nor the expense to travel to Referral hospitals
- 2. Health Professionals lack the "tools" to give better health care

What issues will the project address, and how does the community currently address those issues?

1. The Project will address the scarcity of much needed medical equipment to health Centres and thus provide better health delivery. Currently, the Health Centres refer patients to higher level hospitals or make do with the little that is available. They also ask for more equipment from Government who are unable to adequately meeting the demand due to funding problems.

The needs were assessed through discussions with heads of the Facility and Department heads. The Assessment also involved visits to every section of the Facility to see what equipment was available and what was lacking. This gave a very accurate assessment of the requirements of each Facility and once the donations are received, they will make a huge impact.

The government of the Republic of Zambia through the Ministry of Health pledged to take all donations as Government property that will fall within their service and maintenance schedules hence ensuring sustainability of the Project. Host Rotarians will also go to facilities, months after the donation to check on the state of equipment and if need be, discuss with Health Professionals.
